Re: Hammond Music Service Songlearning Legacy -Major Works – chorale song learning tracks/License and Legal Agreement details. Licensee, Brookdale Concordia Chorale

Explanation:

The following License and Legal Agreement is printed at the bottom of every “Instructions for Use” pdf file for each voice part that is posted on the Chorale’s website. This particular License and Legal Agreement does not apply to Brookdale Concordia Chorale’s License for the 375 Major Works, including numerous significant shorter works that are a part of the digital library. This license agreement only applies to individuals/persons who purchase a particular voice part(s) for their own use. The entire Legacy Library was purchased and donated to the Brookdale Chorale, and therefore a separate license was granted to the Brookdale Chorale, superseding this personal license. Brookdale Concordia Chorale’s license follows the license that does not apply to Brookdale Concordia Chorale.

License that does not apply:

License agreement: Each person who purchases an MP3 download or CD from HMS is licensed to use the **Songlearning Tracks™** of their voice part on their computer or mp3 player and make one backup CD or duplicate for their own use, but may not share, sell or otherwise distribute copies or duplicates of the **Songlearning Tracks™** to anyone else. The act of downloading and/or using the **Songlearning Tracks™** constitutes a License Agreement between Hammond Music Service and each user or choir member that they will honor this License Agreement. License and legal agreement details: Thank you for purchasing **Hammond Music Service Songlearning Legacy™ – Major Works** – a Lifetime Master License for 375 Major Works and significant shorter works! Payment of this invoice constitutes a license agreement between HMS and the invoicees and the individuals who receive duplicates of these Songlearning Tracks™, under which the invoicees and the chorus members who use these Songlearning Track duplicates may not copy, share, loan, sell, rent or lease any of the Songlearning Tracks™ to anyone outside of your choral group. The only exception to this rule is when another choir collaborates with your choir – learning the same work concurrently, at which time you may share duplicated CDs and/or MP3s with the collaborating choir. The collaborating choir must agree to not share the duplicated CDs and/or MP3s with another choir, and may not use them subsequently for rehearsals of the same music. A reminder of this license agreement is printed on the instruction sheet each choir member receives. You are purchasing all the Public Domain publications such as Kalmus, CPDL, and some by G. Schirmer and Novello. All other tracks created from non-Public Domain publications are being **donated/free** to you and your organization, and the non-Public Domain rehearsal tracks may be freely duplicated and distributed under the Fair Use provisions included in the US Copyright Law.
